December 4, 2023:

1. Discussion with possible decision to approve, reject and/or amend a request to amend Ordinance 428 concerning the zoning of a residential area at N Flint St, Hwy 59 and Hwy 51.

Currently the area is zoned residential, and they are asking to change it to mixed use. On the map the shaded area is the area in question. The reason is that the owner of one of the properties in the area is looking to add a billboard in the area and has plans for future development that the current zone would be difficult to work with. It was stated that given the area around the portion in question is already partially commercial and residential it would fall more in line with what is there. Three of the properties in that area are commercial properties and the rest are residential.

Clarification: The area is zoned for residential only and all of the surrounding area is mixed use – residential and commercial. Three of the properties in that area are commercial properties and the rest are residential. This changes the zoning to match the surrounding area.

33. According to OML – Christian Rinehart, Associate General Counsel – the language is correct as the council will be assigning extra duties to an existing employee/position filled by the voters, not by the council. All remuneration has to go through payroll, rather than as contract work (Federal Law), which is the reasoning behind the statement "as an employee of the City of Stilwell." It has to be separately listed as extra duty because the salary for the elected position cannot change until after the next election.
