ORDINANCE NO. 120

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY, AND DESIGNATING SUCH TERRITORY AS THE 1977 NORTH ADDITION TO THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to wit:

A subdivision of that portion of the NE/4, NE/4 of Section 27, Township 16 North, Range 25 East, described as follows: Beginning at the Northwest corner of said NE/4, NE/4; thence South 0 degrees 01' 41" East, 1217.68 feet to the North right-of-way line of Oklahoma State Highway No. 51; thence North 89 degrees 24' 20 East, 255.50 feet; thence 347.45 feet along a curve to the right having a radius of 1289.89 feet; thence North 89 degrees 47' 10" East, 332.80 feet; thence North 17 degrees 50' West, 210.00 feet; thence North 89 degrees 47' 10" East, 105.00 feet to the West right-of-way line of U.S. Highway No. 59; thence South 17 degrees 50' East, 1648.92 feet to the intersection of said West line with the East line of said Section 27; thence North 72 degrees10' East, 1.00 foot; thence North 17 degrees 50' West, 1648.92 feet; thence South 72 degrees 10' West, 1.00 foot; thence North 17 degrees 50' West, 1128.15 feet to the North line of said Section 27; thence South 89 degrees 47' 10" West, 630.20 feet to the point of beginning,

a plat of which said property is attached hereto and made a part hereof as though described herein.

SECTION 2. That the real property herein described shall be designated as the 1977 NORTH ADDITION to the City of Stilwell, Oklahoma, and the boundaries of said City are herewith changed to correspond to the legal description first above given.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. WHEREAS, an immediate necessity exists; therefore, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force and effect from and after its passage and approval.
