ORDINANCE NO. 127

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN PROPERTY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY'S BOUNDARY TO INCLUDE SUCH TERRITORY, AND DESIGNATING SUCH TERRITORY AS THE SOUTHERN ESTATES NO. TWO ADDITION TO THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to wit:

A portion of land located in Section 3, Township 15 North, Range 25 East, Indian Base and Meridian, Adair County, Oklahoma, more particularly described as follows, to wit: Commencing at the Northwest corner of the NW/4, NW/4, SW/4 of Section 3, Township 15 North, Range 25 East, Indian Base and Meridian, Adair County, Oklahoma; thence North 89 degrees 39' 26" East a distance of 1477.80 feet to a point; thence South 00 degrees 01' 00" East a distance of 795.00 feet to the point of beginning; thence South 00 degrees 01' 00" East, a distance of 525.40 feet to a point; thence North 89 degrees 38' 53" East a distance of 114.97 feet to a point; thence North 00 degrees 08' 22" East a distance of 329.75 feet to a point; thence South 89 degrees 39' 01" West a distance of 925.68 feet to a point; thence North 00 degrees 01' 00" East a distance of 145.23 feet to a point; thence South 89 degrees 39' 26" West a distance of 60.00 feet to a point; thence North 00 degrees 01' 00" East a distance of 100 degrees 39' 26" West a distance of 50.36 feet to a point; thence South 89 degrees 39' 26" West a distance of 130.00 feet to the point of beginning, containing 9.23 acres, more or less,

a plat of which said property is attached hereto and made a part thereof as though described herein.

SECTION 2. That the real property herein described shall be designated as the **SOUTHERN ESTATES NO. TWO ADDITION** to the City of Stilwell, Oklahoma, and the boundaries of said City are herewith changed to correspond to the legal description first above given.

SECTION 3. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

SECTION 4. WHEREAS, an immediate necessity exists; therefore, for the preservation of the public peace, health and safety, an emergency is hereby declared to exist by reason whereof this Ordinance shall be in full force and effect from and after its passage and approval.

ORDINANCE NO. 128

AN ORDINANCE PROVIDING FOR AN INCREASE IN THE SALARY OF THE MAYOR, CITY COUNCIL AND CLERK-TREASURER OF THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. That the salary of the Mayor of the City of Stilwell, Oklahoma, shall be increased to provide a salary in the sum of \$400.00 per month, effective at the beginning of the next term of office.

SECTION 2. That the salary of the Councilmen of the City of Stilwell, Oklahoma, shall be \$100.00 per month for each regular meeting attended and \$25.00 per month for each special meeting attended.

SECTION 3. That the salary of the City Clerk-Treasurer shall be \$700.00 Per month, effective at the beginning of the next term of office.

SECTION 4. That all elected City officials shall be entitled to be reimbursed for actual expenses incurred by them on trips and meetings while acting for the benefit of the City of Stilwell, Oklahoma, said expenses to be submitted by claim as provided by law.

SECTION 5. That all ordinances and parts of ordinances in conflict herewith are hereby repealed.
