## ORDINANCE NO. 63

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF CERTAIN TERRITORY TO THE CITY OF STILWELL, OKLAHOMA, AND CHANGING THE CITY BOUNDARY TO INCLUDE SUCH TERRITORY, AND DESIGNATING SUCH TERRITORY AS THE CITY SUBDIVISION TO THE CITY OF STILWELL, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF STILWELL, OKLAHOMA:

SECTION 1. That the following described real property situate adjacent to and abutting upon the present corporate limits of the City of Stilwell, Oklahoma, shall be annexed to and become part of the City of Stilwell, Oklahoma, to wit:

#### TRACT ONE

The NW/4, SE/4, NW/4 and the NE/4, SW/4, NW/4 and the East 420 feet of the NW/4, SW/4, NW/4 of Section 34, Township 16 North, Range 25 East.

#### TRACT TWO

Beginning at a point 245 feet West of the Southeast corner of the NE/4, NW/4 of Section 34, Township 16 North, Range 25 East; thence in a Westerly direction a distance of 250 feet; thence in a Southerly direction a distance of 175 feet; thence in an Easterly direction 250 feet; thence in a Northerly direction a distance of 175 feet to the point off beginning; and A piece of land described as follows: beginning 16 feet South of the Northwest corner of the above described tract of land; thence

the Northwest corner of the above described tract of land; thence in a Westerly direction 55 feet; thence in a Southwesterly direction to a point 130 feet South of the Northwest corner of the NE/4, SE/4. NW/4; thence in a Northerly direction 130 feet to the Northwest corner of said NE/4, SE/4, NW/4; thence in an Easterly direction 165 feet; thence in a Southerly direction to the point of beginning; and

A part of the SE/4, NW/4 of Section 34, Township 16 North, Range 25 East, more particularly described by metes and bounds as follows: Beginning at a point 90 feet West of the Northeast corner of the SE/4, NW/4 of Section 34, Township 16 North, Range 25 East, thence South 350 feet; thence West 405 feet; thence North 175 feet; thence East 155 feet to the place of beginning.

## TRACT THREE

A tract of land 25 feet on the North side of a line described as follows: Beginning at a point 25 feet West of the Southeast corner of SE/4, SW/4, NE/4 of Section 34, Township 16 North, Range 25 East; thence West 547 feet; and

A tract of land 25 feet on either side of a line described as follows: A tract of land described as follows: SW/4, NE/4 of Section 34, Township 16 North, Range 25 East, more particularly described as beginning at a point which is 547 feet West of the Southeast corner of the SW/4, NE/4 of Section 34, Township 16 North, Range 25 East; thence in a Northwesterly direction 1,051 feet to a point which is 584 feet South of the Northwest corner of the SW/4, NE/4 of Section 34, and is on the West line of said SW/4, NE/4 of Section 34, Township 16 North, Range 25 East.

#### TRACT FOUR

A tract of land 25 feet on the South side of a line described as follows: Beginning at a point 25 feet West of the Northeast corner of NE/4, SW/4, SW/4 of Section 34, Township 16 North, Range 25 East, thence West 547 feet.

# TRACT FIVE

A tract of land 25 feet on either side of a center line described as follows: The NE/4, SE/4, NW/4 of Section 34, Township 16 North, Range 25 East; more particularly described as: Beginning at a point 540.8 feet South and 29 feet West of the Northeast corner of the SE/4, NW/4 of Section 34, Township 16 North, Range 25 East; thence in a Northwesterly direction to a point which is 90 feet West and approximately 338 feet South of the North corner of the SE/4, NW/4 of Section 34, Township 16 North, Range 25 East,

a plat of which said property is hereto attached and made a part hereof as though described herein.

SECTION 2. That the real property herein described shall be designated as the CITY SUBDIVISION of the City of Stilwell, Oklahoma.
