

ORDINANCE NO.94-A

AN ORDINANCE CONSENTING TO THE INCLUSION OF THE AREA WITHIN THE CORPORATE LIMITS OF THE CITY OF STILWELL, OKLAHOMA, WITHIN THE TERRITORY OF PROPOSED SOLID WASTE MANAGEMENT DISTRICT NO. 1, ADAIR COUNTY, OKLAHOMA: AUTHORIZING AND DIRECTING THE MAYOR OF SAID CITY TO PETITION THE BOARD OF COUNTY COMMISSIONERS OF ADAIR COUNTY, OKLAHOMA, ON BEHALF OF SAID CITY TO CREATE SAID SOLID WASTE MANAGEMENT DISTRICT NO. 1, ADAIR COUNTY, OKLAHOMA; AND DECLARING AN EMERGENCY.

WHEREAS, the City of Stilwell, Oklahoma, is without adequate solid waste management system to serve the citizens and residents of said City; and

WHEREAS, a waste disposal system to serve the citizens and residents of said City can best be obtained by cooperating with rural residents in the incorporation of a Solid Waste Management District pursuant to the provisions of the Oklahoma Rural Water, Sewer and Solid Waste Management Districts Act, as amended (82 O.S. Supp. 1972, SS 1324.1-1324.26); and

WHEREAS, the City of Stilwell, Oklahoma, the Town of Westville, Oklahoma, and the Town of Watts, Oklahoma, propose to sign a Petition for the incorporation for presentation to the Board of County Commissioners of Adair County, Oklahoma, such District to embrace the lands described in said Petition, including the area within the corporate limits of the City of Stilwell, Oklahoma, as well as areas outside the corporate limits of said City, which Petition is now on file with the City Clerk; and

WHEREAS, the City Council has examined the Petition and determined that the public health, convenience, safety and welfare of the citizens of said City will be protected and promoted by including said City in the proposed Solid Waste Management District; and

WHEREAS, the City Council desires to consent, as required by law, that the City of Stilwell, Oklahoma, having a population of 2280 persons according to the last decennial census, be included within the boundaries of the proposed Solid Waste Management District and to authorize and direct the Mayor of said City to sign and execute the Petition for and on behalf of said City;

**NOW, THEREFORE,
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF STILWELL, STATE OF OKLAHOMA:**

SECTION 1. That the City of Stilwell, Oklahoma, hereby consents to the inclusion of all of the area within its corporate limits with the territory of proposed Solid Waste Management District No. 1, Adair County, Oklahoma, said territory being more particularly described as follows:

- The Incorporated City of Stilwell, Oklahoma
- The Incorporated Town of Westville, Oklahoma
- The Incorporated Town of Watts, Oklahoma
- Township 18 North, Range 25 East, Sections 12, 13, 24, 25, and 36
- Township 17 North, Range 25 East, Sections 1, 12, 13, 23, 24, 26, 27, and 34
- Township 16 North, Range 25 East, Sections 3, 10, 15, 16, 22, 26, 27, 34 and 35
- Township 19 North, Range 26 East, Sections 19, 30 and 31
- Township 18 North, Range 26 East, Sections 6, 7, 18, 19, 30 and 31
- Township 17 North, Range 26 East, Sections 6 and 7

SECTION 2. That the City of Stilwell, Oklahoma, shall be one of the Petitioners for the creation of Solid Waste Management District No. 1, Adair County, Oklahoma, and that the Mayor of the City is hereby authorized and directed to sign and execute the Petition for and on behalf of the City, file the petition with the Board of County Commissioners of Adair County, Oklahoma, and take such further action as may be necessary to incorporate and organize said District.

SECTION 3. EMERGENCY.

WHEREAS, an immediate necessity exists for the passage of this Ordinance; therefore, for the preservation of public peace, health and safety, an emergency is hereby declared to exist, and, by reason of same, this Ordinance shall be in full force and effect from and after its passage and approval.
