ORDINANCE NO. 352

AN ORDINANCE CLOSING PORTIONS OF STREETS, PUBLIC RIGHTS-OF-WAY AND ALLEYWAYS LYING WITHIN THE FAIRVIEW ADDITION TO THE CITY OF STILWELL, ADAIR COUNTY, OKLAHOMA, AND REPEALING ANY ORDINANCE IN CONFLICT THEREWITH AND DECLARING AN EMERGENCY

Be it ordained by the Mayor and the Council of the City of Stilwell, Oklahoma:

<u>Section 1.</u> That all of the following described portion of Fairview Addition to the City of Stilwell, Adair County, Oklahoma, is no longer necessary for public use for streets, rights-of-way and alleyways purposes and the same shall be and is hereby closed for streets, rights-of-way and alleyways purposes; provided however, the City retains its utility easements within said streets, rights-of-way and alleyways, to-wit:

Oak Street lying between Blocks 3 and 4, and Blocks 2 and 5 of Fairview Addition to the City of Stilwell;

Maple Street lying between Blocks 4 and 9 and Blocks 5 and 8 of Fairview Addition to the City of Stilwell;

The Northerly one-half (1/2) of Walnut Street lying adjacent to Block 9 and Block 8 of Fairview Addition to the City of Stilwell;

Oklahoma Avenue lying between Block 9 and Block 8, Block 4 and Block 5 and Block 3 and Block 2, of Fairview Addition to the City of Stilwell;

All alleyways located in Blocks 2, 3, 4, 5, 8 and 9 of Fairview Addition to the City of Stilwell;

Elm Street lying Between Block 10 and Block17 of Fairview Addition to the City of Stilwell;

Cedar Street lying between Block 17 and Block 18 of Fairview Addition to the City of Stilwell;

All alley ways located Blocks 10 and 17, lying between Lots 5, 6, 7, 8, 9 and 10, Bock 18 of Fairview Addition to the City of Stilwell;

The Northerly one-half of Locust Street lying adjacent to Lots 8, 9 and 10, Block 18 of Fairview Addition to the City of Stilwell.

Being the intention to vacate all public rights-of-way and alleyways lying within the following described property:

TRACT 1:

Lots One (1), Two (2), Three (3), Four (4), Five (5) and Six (6), in Block Two (2), FAIRVIEW ADDITION to the town of Stilwell, Adair County, Oklahoma.

Lots One (1), Two (2), Three (3), Four (4), Five (5), Six (6), Seven (7), Eight (8), Nine (9), Ten (10), Eleven (11) and Twelve (12), in Block Eight (8), FAIRVIEW ADDITION to the town of Stilwell, Adair County, Oklahoma.

TRACT 4:

Lots One (1), Two (2), Three (3), and Four (4), in Block Eleven (11), FAIRVIEW ADDITION to the town of Stilwell, Adair County, Oklahoma.

TRACT 5:

Lot Six (6), in Block Twelve (12), FAIRVIEW ADDITION to the town of Stilwell, Adair County, Oklahoma.

TRACT 6:

Lot Fourteen (14), and the East Half (E/2) of Lot Thirteen (13), in Block Ten (10) FAIRVIEW ADDITION to the town of Stilwell, Adair County, Oklahoma.

TRACT 7:

Block Five (5) of the INDUSTRIAL PARK ADDITION to the City of Stilwell, Adair County, Oklahoma.

The North Half (N/2) of the Southeast Quarter (SE/4) of the Southwest Quarter (SW/4) less 6 acres for railroad right-of-way, and the South Half (S/2) of Northwest Quarter (NW/4) of the Southeast Quarter (SE/4), and the North Half (N/2) of the Southwest Quarter (SW/4) of the Southeast Quarter (SE/4) of Section Thirty-five (35), Township Sixteen (16) North, Range Twenty-five (25) East, Adair County, Oklahoma.

<u>Section 2.</u> Any ordinances or part of ordinances in conflict with this Ordinance are hereby expressly repealed.

<u>Section 3.</u> An emergency is hereby declared to exist by reason whereof it is necessary to the immediate preservation of the public health and safety of the City of Stilwell, Oklahoma, that this Ordinance shall take effect from and after its passage and approval.
