## CITY OF STILWELL ORDINANCE NO. 392

**AN ORDINANCE PROVIDING FOR COMPENSATION OF ALL ELECTED OFFICIALS IN AND FOR THE CITY OF STILWELL REPEALING ALL OTHER ORDINANCES IN CONFLICT HEREWITH.**

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, STATE OF OKLAHOMA:

**SECTION 1.** That the compensation of the Mayor of the City of Stilwell, Oklahoma shall be the sum of \$3000 per month, effective at the beginning of the next term of office of the Mayor which is May 1, 2019.

**SECTION 2.** That the compensation of the City Council Members of the City of Stilwell, Oklahoma shall be the sum of \$500 per month, effective at the beginning of the next term of office of each City Council Member which is May 1, 2019 for Wards Two, Three, and Five, and May 1, 2021, for Wards One and Four.

**SECTION 3.** That the compensation of the City Clerk-Treasurer of the City of Stilwell, Oklahoma shall be the sum \$2400 per month, effective at the beginning of the next term of office of the City Clerk-Treasurer which is May 1, 2019.

**SECTION 4.** The person who serves as City Clerk-Treasurer is hereby appointed to perform additional administrative special duties not specified by State law as an employee of the City of Stilwell.

A. Such duties shall include:

- a. Review and make recommendations to the city council for revising, modifying, updating, expanding and reforming the Personnel Policy of the City of Stilwell, including, but not limited to, Workmen's Compensation, Disciplinary Actions, FMLA/FLSA and any other needs of policy revision as mandated by the council.
- b. Seek grant funding available to municipalities applicable to all city functions and report to the council the best available means by which to apply for and obtain grant funds.
- c. Explore/study the various revenue sources and report to the council as to these sources making recommendations as to any changes for the council's consideration.

B. The pay period for performing the additional administrative duties shall be the same as for other municipal employees and shall be paid each pay period the amount of \$1000 in accordance with any personnel policy or other policy of the City of Stilwell. The salary for performing the additional administrative duties shall not be subject to constitutional restrictions and shall be effective May 1, 2019.

**SECTION 5.** All ordinances and parts of ordinances in conflict herewith are hereby cancelled and repealed effective May 1, 2019.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STILWELL, STATE OF OKLAHOMA:

**SECTION 1.** That the compensation of the Mayor of the City of Stilwell, Oklahoma shall be the sum of \$3000 per month, effective at the beginning of the next term of office of the Mayor which is May 1, 2019.

**SECTION 2.** That the compensation of the City Council Members of the City of Stilwell, Oklahoma shall be the sum of \$500 per month, effective at the beginning of the next term of office of each City Council Member which is May 1, 2019 for Wards Two, Three, and Five, and May 1, 2021, for Wards One and Four.

**SECTION 3.** That the compensation of the City Clerk-Treasurer of the City of Stilwell, Oklahoma shall be the sum \$2400 per month, effective at the beginning of the next term of office of the City Clerk-Treasurer which is May 1, 2019.

**SECTION 4.** The person who serves as City Clerk-Treasurer is hereby appointed to perform additional administrative special duties not specified by State law as an employee of the City of Stilwell.

A. Such duties shall include:

- a. Review and make recommendations to the city council for revising, modifying, updating, expanding and reforming the Personnel Policy of the City of Stilwell, including, but not limited to, Workmen's Compensation, Disciplinary Actions, FMLA/FLSA and any other needs of policy revision as mandated by the council.
